NOTICE OF RACE

1 - RULES —

The regatta will be run in accordance with the 2009-2012 Interscholastic Sailing Association Procedural Rules, this Notice of Race, and the Sailing Instructions.

2 - ELIGIBILITY AND ENTRY —

2.1 - This regatta is open to all High School Sailors (grades 8-12) and will be sailed with school teams of two 420's.

2.2 - Eligible competitors (skippers and crew) may enter by completing the attached entry form and bringing it to practice by May 27th or e-mailing it to jimsorbie@centurytel.net by 9:00PM on MAY 27th. There will be a \$10 Late fee applied to all who apply after 9:00 PM Thursday May 27th.

2.3 - TACS **will** supply boats on a rotation basis.

2.4 Parents are encouraged to attend as this venue will enable viewing of all the races.

3 - FEES — there will be no fees charged to members of the TACS High School Sailing Team.

4.1 - Registration and setup — 12:30 to 1:00 PM

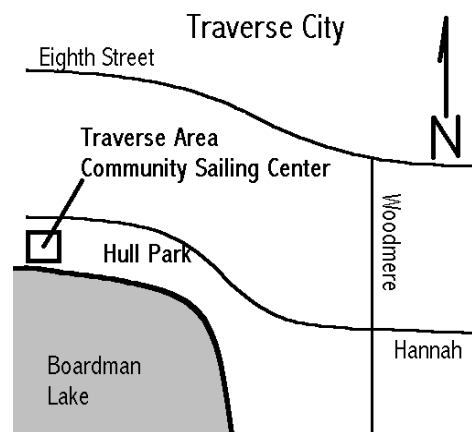
4.2 - Skippers meeting — 1:00 PM

6 - VENUE — The regatta will be held on Boardman Lake in Traverse City, Michigan. The TACS Site is located at Hull Park and is accessible from the corner of Woodmere and Hannah St's just South of the Traverse Area District Library. See map.
